MUST be in uniform for final out-processing appointment.

PT test must be current at least 42 days past my RNLTD. If it expires prior to that date, member must retest prior to my final out-processing appointment. If my PT scores are not current at least 42 days past my RNLTD, Member will NOT be allowed to out-process even if they intend on reporting to my next base prior to my RNLTD.

If member is placed on a profile or medical hold that will expire after their departure date, Member must provide an AF Form 422 or medical clearance memorandum signed by their provider at their final out-processing appointment. The document provided must specifically state that they are cleared to PCS and must be dated after member was put on the profile/medical hold
